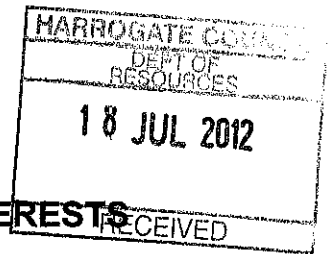

**2. SPONSORSHIP**

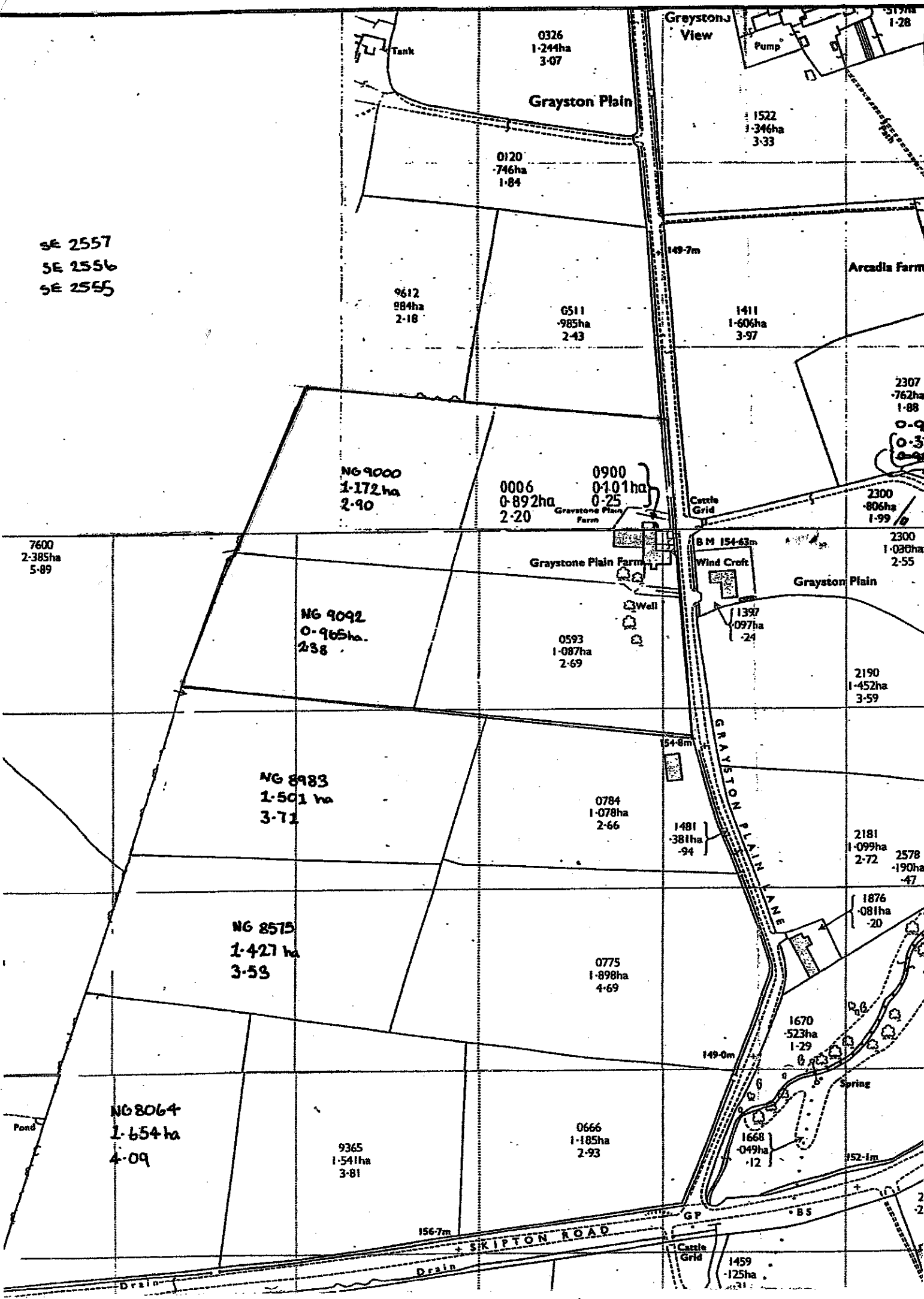
